

Express of Opinion statement

To the stakeholders of PZ Cussons plc

EcoAct was engaged by PZ Cussons plc (PZ Cussons) of Manchester Business Park, 3500 Aviator Way, Manchester, M22 5TG, to provide independent third-party opinion of its implemented data reporting methodology and calculations associated with their GHG Scope 3 emissions for the period 1st June 2020 to 31st May 2021 (FY21).

Objective & responsibilities

The objective of this assessment was to confirm whether the recalculation of PZ Cussons GHG Scope 3 emissions for the FY21 baseline incorporated the updated methodology for data reporting procedures and implementations as outlined in the PZ Cussons boundaries and data mapping FY21 report.

PZ Cussons, with the support of its third-party GHG reporting consultants Verco Advisory Services Ltd, are responsible for the preparation and presentation of its GHG Scope 3 emissions data, the data sources and the development and maintenance of processes and procedures. The EcoAct verification team's responsibility is to express an independent opinion on the accuracy and consistency of the revised GHG Scope 3 emissions reported by PZ Cussons for FY21, and its alignment with the enhanced methodology and procedures.

Assessment criteria and description of activities

An assessment of the revised GHG Scope 3 emissions for FY21 developed by PZ Cussons was undertaken to ensure updates to the calculations were aligned with to the implemented GHG emissions reporting methodology and compliant with relevant GHG Reporting guidelines for data reporting practices. The review of the underlying source data used to compile the revised GHG Scope 3 emissions data for FY21 was outside the scope of this assessment, therefore verification of primary evidence was not conducted.

EcoAct performed a thorough and objective review of the relevant information gathered for this assessment. The assessment process encompassed data validation techniques; improved data accuracy and consistency; enhanced data transparency and the impact of overall FY21 Scope 3 emissions initially reported against the revised calculations carried out in April 2023.

Reports listed below were evaluated to form the basis for our verification opinion

- PZ Cussons_boundaries and data mapping refreshed FY21
- PZ Cussons_boundaries and data mapping FY23

Assessment Opinion

Based on the data and information provided by PZ Cussons and the processes and procedures followed, nothing has come to EcoAct's attention to indicate that the revised GHG Scope 3 emissions totals reported for FY21 are not fairly stated or were not calculated in alignment with the enhanced methodology.

Assessment findings

Due to changes in the methodology approach, the revised GHG Scope 3 emission totals for FY21, resulted in a decrease of 12% in comparison to the Scope 3 emissions initially reported in April 2023. The decrease was a result of improved data quality and reporting procedures, including use of actual activity data as basis of the calculations, standardisation of data reporting across BUs and

rectification of errors identified in the Scope 3 emissions initially reported in the original FY21 baseline. Corrections to data errors were mostly related to downstream transportation and distribution, waste generated in operations and business travel.
